Description of Change:

Cypress is pleased to announce the qualification of the new 2Mb Serial Peripheral Interface (SPI) and parallel asynchronous F-RAM product series.

Cypress will be discontinuing the existing 2Mb SPI and parallel asynchronous F-RAM product series. The list of affected part numbers with replacement part numbers, Last Time Buy (LTB), and Last Time Ship (LTS) dates are provided in an attachment to this notification.

New datasheets have been issued for the new part numbers. Datasheets for both the old and the new part numbers can be downloaded from the Cypress web site by going to <u>www.cypress.com/nonvolatile/</u> and clicking on the "Datasheets" link in the "Related Documentation" section on the right-hand side of the webpage. Datasheet changes are listed in an attachment to this notification.

The new 2Mb SPI and parallel asynchronous F-RAM product series will have Copper Palladium (CuPd) wire bonds. Devices with date codes after 1437 will have a "C" top marked in the lower right hand corner of the device to designate CuPd wire bonds. The new 2Mb SPI and parallel asynchronous F-RAM product series will also be packaged and rated as Moisture Sensitive Level (MSL) 3.

Benefit of Change:

The new products will provide a higher level of quality and reliability. Cypress may add a top passivation layer to the new devices.
